This article analyzes the issues of creating the possibility of simultaneously and promptly sending draft legal acts to all interested ministries, departments, and local executive authorities for consideration, approval (approval) using an electronic digital signature, including for conducting their broad public and expert discussion, as well as using a single electronic database in the formation of information, analytical and statistical data.

Legal acts, as defined in the law "On normative legal acts", are generally binding instructions of authorized state bodies and officials. They fix, change and cancel the norms of law (law, code, decree, decree, instruction, etc.) [1].

The active involvement of legal services of state bodies and organizations in the process of drafting normative legal acts is one of the most pressing problems of our time. The active involvement of all state bodies and organizations in the work of legal services for the most optimal and rational adoption of each draft law is a significant result of the correct approach to the issue. For the long and consistent work of the adopted laws, it is necessary that the draft laws not only pass sufficient discussion by the general public and specialists in the field, but also receive the opinions of foreign experts. Based on the needs and proposals of the informatized society, it is necessary to effectively use the capabilities of information systems created by e-government [2].

The main purpose of this work is to highlight the opportunities and requirements for a single electronic system that provides for the consideration of draft regulatory legal acts, improving the efficiency of electronic document management, and the principles of statistical and information analysis of document management. Also, one of the main tasks of the work is to substantiate the legal support of the unified electronic information system [3].

Based on the above, as the main tasks, it is advisable to designate:

management, monitoring and real-time control of the process of developing draft legal acts and approval (approval) with interested ministries, departments and local executive authorities;

significant savings in time and labor resources in the process of developing draft regulatory legal acts and their approval (approval) with interested ministries, departments and local executive authorities.

At the same time, despite the fact that a number of measures were taken to implement the unified electronic system, individual ministries, departments, local executive authorities and other organizations were able to ensure the high-quality organization and full implementation of the unified electronic system [4].

Requirements for ensuring information security when using a single electronic system.

- Development of a draft regulatory legal act.
- Placement of the electronic form of the draft regulatory legal act in a single electronic system for public discussion.
- Sending the draft regulatory legal act for approval in accordance with the established procedure on paper or in electronic form using an electronic digital signature through a single electronic system.

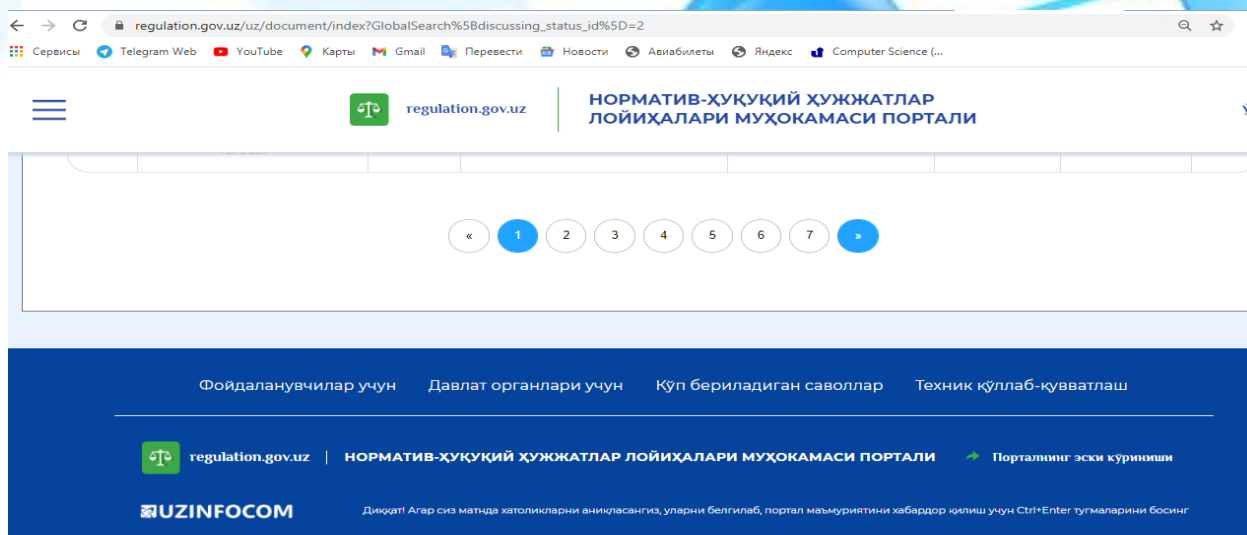
Adoption of a draft regulatory legal act on paper or in electronic form through a single electronic system [5].

- Adoption of a draft regulatory legal act for office work in accordance with the established procedure by means of departmental electronic document management on paper or in electronic form.

- Consideration of the draft regulatory legal act. Preparation of proposals, objections or a positive conclusion based on the results of the review.

- Approval (signing) of the draft regulatory legal act in accordance with the established procedure on paper or in electronic form using an electronic digital signature through a single electronic system.

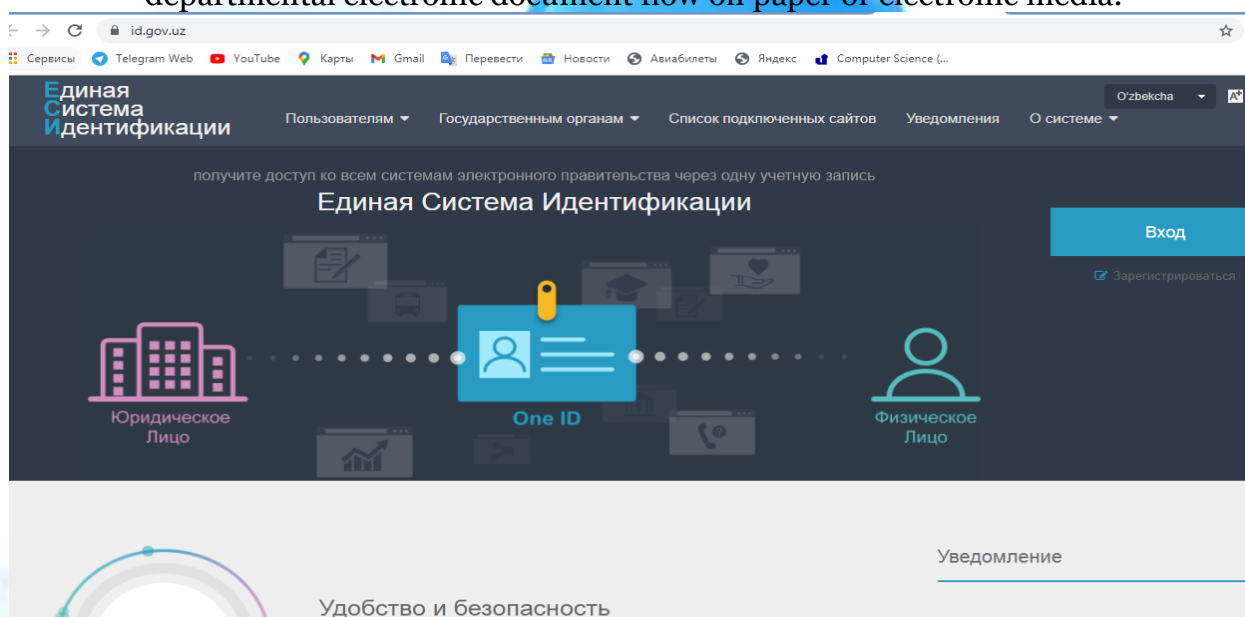
- Sending an agreed (signed) draft regulatory legal act in paper form or in electronic form through a single electronic system to the developer or returning it for revision.

2. Adoption of an agreed regulatory legal act in the prescribed manner in the office work in the departmental electronic document flow on paper or electronic media.

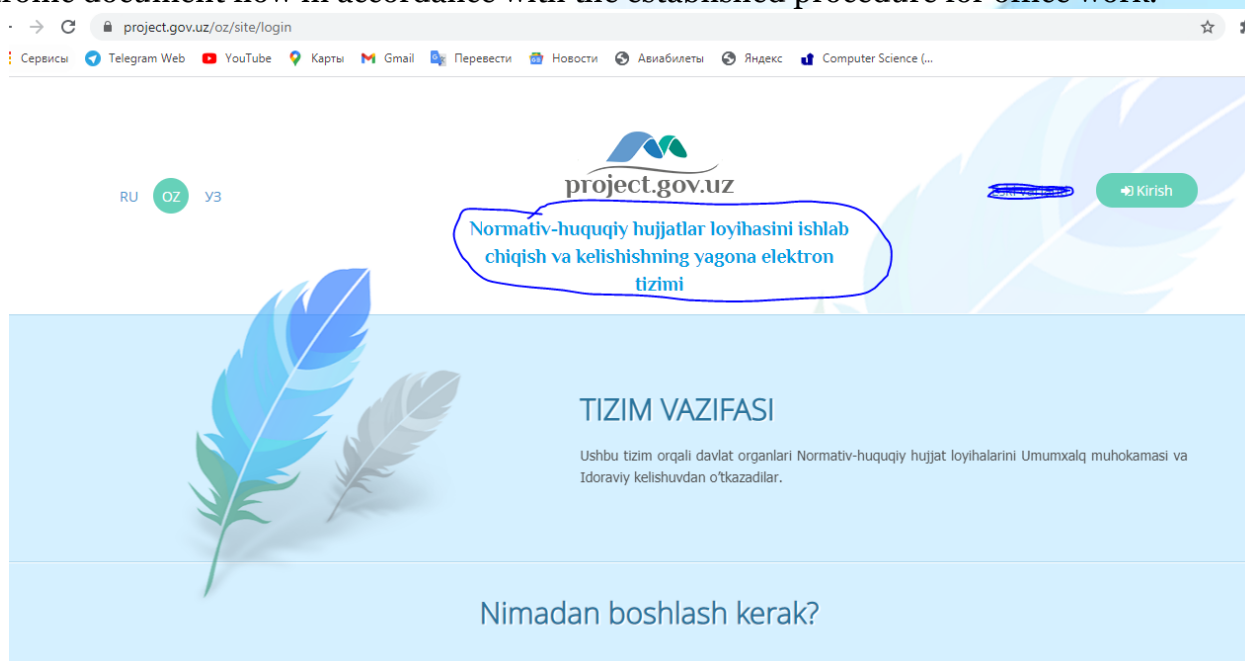


Processing of the draft regulatory legal act in accordance with the established procedure on the basis of received proposals and objections (if necessary).

Sending the final version of the draft regulatory legal act on the basis of proposals through the unified electronic system to the Ministry of Justice in accordance with the established procedure on paper or electronic media with the necessary documents attached.

Adoption of a regulatory legal act in paper or electronic form through a single electronic system in accordance with the established procedure.

Adoption of a draft regulatory legal act in paper or electronic form in the departmental electronic document flow in accordance with the established procedure for office work.



Conducting a legal examination of the draft regulatory legal act and preparing a legal opinion.

Issuance of a legal opinion on a draft regulatory legal act on paper or in electronic form through a single electronic system by means of an electronic digital signature in accordance with the established procedure.

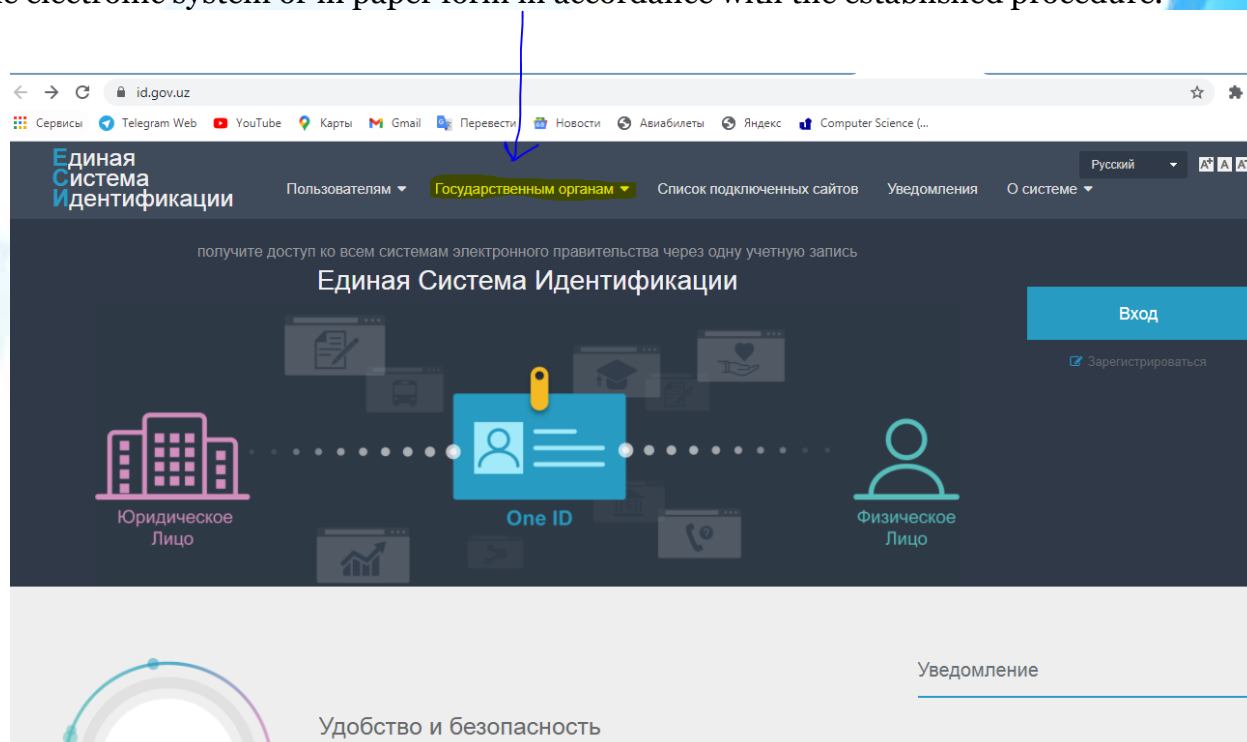
Adoption in accordance with the established procedure of the draft legal act and legal opinion on paper or in electronic form through a single electronic system.

Adoption of a draft regulatory legal act and a legal opinion on paper or electronic media in accordance with the established procedure for office work in the departmental electronic document flow.

Thorough elaboration and preparation of the final version of the draft regulatory legal act (if necessary) based on the proposals of the Ministry of Justice.

Submission of the draft regulatory legal act in paper or electronic form through the unified electronic system to the Cabinet of Ministers in accordance with the established procedure.

Acceptance of the draft normative legal act in the office work in electronic form through a single electronic system or in paper form in accordance with the established procedure.



Agreed upon in accordance with the procedure established by law, financial and economic, and consideration of the draft regulatory legal act that has passed legal expertise.

If necessary, return the draft regulatory legal act to the developer in electronic form or in the prescribed manner in paper form through a single electronic system for further careful study.

Preparation of a draft legal act in accordance with the established procedure on paper for informing the leadership of the Cabinet of Ministers and the defense.

The draft regulatory legal act approved by the leadership of the Cabinet of Ministers' office is submitted in accordance with the established procedure on paper and its copy in electronic form for approval or sending to the Administration of the President of the Republic of Uzbekistan for adoption [6].

Adoption of the draft normative-legal act and the conclusion of the Administration of the President of the Republic of Uzbekistan for production on paper in accordance with the established procedure.

Thorough elaboration of the draft legal act, taking into account the final proposals of the Presidential Administration of the Republic of Uzbekistan (if necessary).

Submission of the draft regulatory legal act to the management of the Cabinet of Ministers office in paper form for review.

Preparation of a draft government document in paper form for signing, and laws and acts of the President of the Republic of Uzbekistan-for approval with the Prime Minister and direction for adoption in accordance with the established procedure [7].
