**Annotation:** The article analyzes the role of non-governmental organizations and other institutions of civil society in achieving sustainable development goals.

It is known that public institutions are defenders of the interests of different segments of the population.

According to the Law of the Republic of Uzbekistan "On Non-Governmental Organizations", a non-governmental non-profit organization is a self-governing organization established on a voluntary basis by individuals and (or) legal entities that does not pursue the extraction of income (profit) as the main purpose of its activities and does not distribute the received income (profit) among its participants (members). A non-governmental non-profit organization is created to protect the rights and legitimate interests of individuals and legal entities, other democratic values, achieve social, cultural and educational goals, meet spiritual and other non-material needs, carry out charitable activities, and for other socially useful purposes [1].

Civil institutions are a distinctive feature of civil society in Uzbekistan. These criteria mainly include:

- representation (protection) of the interests of citizens;
- organization on the initiative and will of the people, the population (state support of this principle does not cancel);
- establish self-government in them;
- that membership or withdrawal is a voluntary right of every individual;

The role of public institutions in socio-political life has been studied in works such as M. Sharifkhodjaev, R. A. Ubaidullayeva, E. Khalilov, H. T. Odilkoriev, Sh. Mamadaliyev, F. Musayev, A. Huseynova.

It should be noted that over the past five years, as a result of the targeted implementation of a number of measures to liberalize the economy of Uzbekistan and transition to a market economy, great progress has been made. The proof of this is the positive changes in the social, economic and political spheres that occur in the life of every citizen of the Republic of Uzbekistan [2].
